# MEETING CALLED TO ORDER WITH THE PLEDGE OF ALLEGIANCE AT 6:30 p.m.

#### A. LIMITED PUBLIC COMMENT: None

#### B. APPROVAL OF AGENDA:

Motion by Jenema, support by White to approve agenda as presented. Motion carried unanimously.

## C. INQUIRY AS TO CONFLICTS OF INTEREST:

White expressed a possible conflict with one of the web designers, JS Interactive. Zollinger commented that we will address the issue when we get there on the agenda.

#### D. NEW BUSINESS:

Jenema summarized the memo she prepared for the Board. Discussion followed.

### E. OLD BUSINESS:

1. <u>Final Approval of Budget General Appropriations Act for 2013-14 with changes as noted in</u> memo for Township supervisor from 6/4/13 meeting

Zollinger commented that in section 10: Transfer Authority, the Chief Administrative Officer (Supervisor) shall not have the authority to make transfers among the various departments without prior Board approval. In previous years Supervisor had the authority to do so upr to %50 of a line item.

Motion by Collett to approve Resolution R-2013-33 Budget General Appropriations Act for 2013-14 with two corrections; Section 12; Payment of Bills, strike and Treasurer may pay, And in Section 7 – Estimated Expenditures, Other Fund strike expenditures. Seconded by Jenema. Motion carried by a roll call vote of 6 in favor (Zollinger, Collett,Scott, Jenema,
