## ACME TOWNSHIP ORDINANCE GRANTING FRANCHISE WATER DISTRIBUTION SYSTEM ORDINANCE NO. <u>2012</u>-02

An Ordinance to grant a non-exclusive franchise to the Township of East Bay to construct and maintain water distribution facilities within the Township of Acme.

## THE TOWNSHIP OF ACME ORDAINS:

There is hereby adopted an Ordinance granting to the Township of East Bay, a Michigan municipal corporation, a non-exclusive franchise to construct and maintain water distribution facilities within the Township of Acme, pursuant to the following terms of the franchise:

## SECTION I

## Grant of Franchise

The Township of Acme, State of Michigan, hereinafter referred to as Grantor, hereby grants to the Township of East Bay, hereinafter referred to as Grantee, a non-exclusive franchise to construct, repair, maintain and operate a water distribution system within the franchise area described in Section II below in the Township of Acme. The previous franchise granted to East Bay Township for a Water Distribution System is hereby repealed in its entirety and replaced with this franchise.

## **SECTION II**

## Franchise Area

This franchise shall be limited to the Township's public highways, streets, alleys or other public places along, through, or adjacent to the shaded area depicted on attached Exhibit A-1, A-2, and A-3.

## **SECTION III**

## Term

The franchise granted by this Ordinance shall be revocable at the will of the Grantor.

## SECTION IV

## Construction and Maintenance Standards

The water distribution system within the franchise area shall be constructed in accordance with standards at least as great as those that are in effect within the Grantor Township from time to time and maintained in accordance with the standard established for the rest of the East Bay Township water distribution system.

East Bay Township shall do no injury to any street, highway, and/or alley, or in any manner disturb or interfere with any other utility, public or private, now or hereafter laid or constructed by any authorized person or corporation.

East Bay Township shall not unnecessarily obstruct the passage of any of the highways, streets, alleys or other public places within Acme Township, and shall repair any opening or excavation within a reasonable time and in as good as a condition as before the opening or excavation was made.

### SECTION V

## Effective Date

This Ordinance shall take effect the day following the date of its publication.

The above Ordinance is adopted this 3rd day of January, 2012.




